**PORTFOLIO OBJECTIVE**

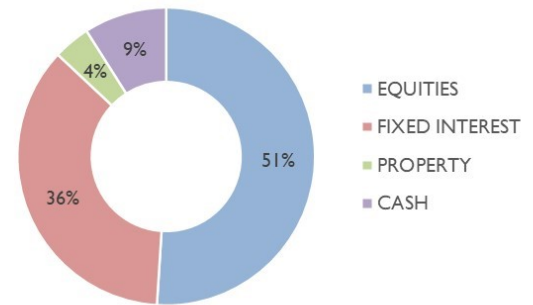
